Please observe the following PPE (Personal Protective Equipment) requirements:

- No open toed shoes may be worn in production areas; high-heeled shoes are not recommended.
- An ESD smock will be provided and must be worn at all times while on the production floor.

Export Controls Compliance

PARPRO is a manufacturer of components that are used in a variety of markets including military, aerospace, and defense. Pursuant to the International Traffic in Arms Regulations (ITAR) and the Export Administration Regulations (EAR), access to these items and their technology is forbidden to individuals who are not US persons, as defined in Part 120.15 CFR 22 Chapter I of the ITAR.

LOBBY ENTRANCE INSTRUCTIONS

To enter the PARPRO lobby you must first enter through a security gate. Guest parking is located opposite the lobby entrance. **Gate Code will be provided by your host before your visit.**



U.S persons must provide acceptable unexpired documentation upon arrival

Acceptable documentation includes the following:

- US Passport
- US Permanent Residency Card
- Driver's License - Real ID
- Global Entry Card Showing US Citizen

Upon check-in at the Reception Area

You will be required to provide documentation supporting your status as a US person. This information is needed in the event of a factory tour. Visitors are asked to observe the following rules:

- Complete a visitor check in each day - Sign in/out on iLobby (via iPad)
- Be escorted at all times throughout the facility by at PARPRO representative
- Wear your PARPRO identification badge - must be visible at all times.

Electronic Devices

All visitors are respectfully asked to comply with the following:

- Cell phones and other electronic devices (smart watches) may be stored outside of the manufacturing floor - in your vehicle or stored in the meeting room.
